Results of Food Service On-Site Reviews

Mrs. Hagner shared that the district is required to conduct, at least annually, food service on-site reviews at all cafeterias for lunch and fifty percent of the cafeterias for breakfast. She shared that she completed the federally required reviews and there were "no" findings of meal counting issues at any of the district's locations. She commended the cafeteria managers and staff for doing an outstanding job each day to provide quality meals for the district's students in a safe and clean environment.

- o July 14, 2020 Cumming was awarded contract to initiate a Comprehensive Facility & Enrollment Study.
- o **October 27, 2020** Demographic and Growth Study presented to YSD1 Board.
- o January 26, 2021 Facility assessment results presented to YSD1 Board.
- o March 8, 2022 Board unanimously passed a resolution to pursue Impact Fees through York County as a means to reduce the amount of a potential bond referendum.
- o October 3, 2022 County Council 1st Reading of Impact Fees (Passed)
- o October 17, 2022 County Council 2nd Reading of Impact Fees (Passed)
- o November 7, 2022 County Council 3rd Reading of Impact Fees (Failed)
- o January 10, 2023 Board unanimously passed a motion to pursue Impact Fees through the City of York as a means to reduce the amount of a potential bond referendum.
- o January 11, 2023 Supt. emailed City Manager & City Council to inform them of YSD1 Board action.
- o January 12 & 18, 2023 Mrs. Webb made several attempts to request a meeting with City Manager, Supt., and Assistant Supt. to discuss process moving forward.
- o January 24, 2023 Meeting held between City & District. Attendees: Dalton Pierce, Mayor Fusser, CM Stephanie Jarrett, CM Matt Hickey, Kelly Coxe, & Amy Hagner. District was told we would be on the upcoming February 6, 2023, for Impact Fee consideration & decision and were asked to have a letter & presentation to the City Manager by 2/1/23 for inclusion in Council Packet.

- January 30, 2023 City Manager emailed K. Coxe to inform District that we would not be on the February 6 agenda. "This item did not get added to the February 6, 2023, City Council meeting agenda based on no request from City Council for the item to be added to the agenda."
- o **January 30, 2023** K. Coxe called City Manager to inquire what the email meant. The call was not returned.
- January 31, 2023 Supt. talked to City Manager, via telephone. City Manager stated that there is "no support as a whole" and that he had "spoken to each Council Member". When Supt. asked City Manager what official response from the City that he would like District to use, he stated, "The City chooses not to take up this issue."
