Mrs. Coxe began her presentation by stating that the focus of the district is protecting the health, safety and well-being of students and staff while giving students the best possible learning experience that is as close to normal as health and safety allows.

Mrs. Coxe shared the latest CDC recommendations for the prevention of COVID19 and the incident trend rate of COVID19 for the zip codes included in the district. She also shared the instructional models that will be offered to students. Option 1 for students is a Virtual Academy; this option is available for students who have access to a keyboard device and strong internet. Option 2 for students is face-to-

face; the face-to-face model is dependent on the spread of COVID19. The face-to-face model includes Traditional (low spread); Hybrid (medium or high spread); and Remote (medium or high spread). She also noted that during the times of medium and high spread that all students and staff will wear face coverings when social distancing is not possible.

In closing, Mrs. Coxe made her recommendation that the district open using the hybrid model.
