## Minutes of Public Presentation of the 2020-2021 Budget York School District One 1475 East Liberty Street York, South Carolina 29745 Tuesday, June 23, 2020

In accordance with the South Carolina Code of Laws, 1976, Section 30-4-80 (d) as amended, *The Herald, Charlotte Observer, WRHI Radio, Cable News Two and News 19 (Columbia)* were properly notified of the date, place, and time for the Public Presentation of the FY 2020-2021 Budget which was held on Tuesday, June 23, 2020 at 5:30 PM at the administrative offices of York School District One located at 1475 East Liberty Street, York, South Carolina. Due to COVID19 and CDC Guidelines, the meeting was not be open to public; however public access to the meeting via conference call was available. The conference call information was provided on the district's website and on BoardDocs.

Chair Howell welcomed everyone to the meeting and thanked them for their attendance. Mrs. Howell stated that Mrs. Hagner would make the presentation, followed by a time for questions. She added the following procedures for questions:

- Individuals will be recognized to speak.
- Those with questions will be asked to state their name and address.
- In the interest of time, the district will allow one question per person. If time permits we will rotate back around for individuals that may have more than one question.
- Since this is a public hearing on the budget, questions or comments should relate to the 2020-2021 budget.

## Public Presentation ......Mrs. Amy Hagner, Assistant Superintendent for Finance & Operations

Mrs. Hagner began her PowerPoint by reviewing historical data including enrollment trends, revenue and expenses.

In addition, Mrs. Hagner shared the following information regarding 2020-2021 expenditures:

- All salary schedules are frozen at the current year's level.
- General Assembly (GA) has suspended step increases for teachers until they pass a budget in September.
  - > If GA approves a step increase for teachers, all employees in the district will receive a step increase, if eligible.
- 1% retirement increase has been suspended.
- Increase in operational and technology costs are included.
- Health insurance increases totals 6.73%.
- 1 new FTE (full time employee) will be added.
  - Pre-school Disabilities
- Average 5K 4<sup>th</sup> Grade Class Size Ratio is 21.5:1.
- Retiree reduction is reduced from 7% to 6%.
- Reimbursement for accrued sick leave over 90 days is included.

In closing Mrs. Hagner stated that the district had a balanced budget for the 2020-2021 year utilizing \$197,384 of the fund balance.
