Fiscal Year 2018-2019 Comprehensive Annual Financial Report

Mr. Queen shared that the district will receive three additional School Resource Officers (SRO) through new State Proviso 1.86 (School Safety Program). Thanks to the collaboration with the City of York Police Department and York City Council, the district will be able to provide an SRO for Harold C. Johnson Elementary School, Hunter Street Elementary and one that will be shared between Jefferson and York Intermediate School.

Grant Update

Mrs. Spangler provided an update to the Board regarding two grants the district recently received.

Duke Energy Foundation offered grants for school supplies to identified high poverty schools across the state. This investment of nearly \$200,000 across Duke Energy's service areas is a first for its foundation. Harold C. Johnson Elementary School received \$700 for the purchase of school supplies for its students.

A grant has been obtained from SC Vocational Rehabilitation Department to fund 2 part-time Transition Services Specialist positions. SCVRD is mandated to deliver transition services in coordination with local school districts for students with disabilities. This grant will enable York Comprehensive High School to provide transition services to meet the needs of both diploma and non-diploma level students with disabilities. Included in these services is job exploration counseling, work-based learning experiences, workplace readiness training, and instruction in self-advocacy. This grant will provide services to a minimum of 12 students with disabilities in grades 10 and up who are at least 16 years of age. However, we hope to serve more than this minimum number. SCVRD will provide a liaison counselor, training and technical assistance for the implementation of this grant. The grant will pay up to \$68,000 for these part-time positions for implementation of these services.

State Report Card Update

Mrs. Bowman shared a brief overview of the state report card. She noted that English Language Arts scores increased by 5 % while Math remained relatively the same.

Parenting Institute

Mrs. Allen provided the Board with an overview of the Early Childhood Parent Institute. Board members were provided a copy of the upcoming institute dates and times as well as a copy of the letter that was sent home to parents inviting them to participate.
